#### EDNA TOWNSHIP MEETING November 17,2020 www.ednatownship.org

The meeting was called to order at 7 p.m. and began with the Pledge of Allegiance.

Dennis Sazama, Gary Schattschneider, Echo Dockter and Karen Marthaler were present. Carol Nelson was absent.

The agenda was reviewed. Sazama made a motion to accept the agenda with the addition of 380th to the road report.

Schattschneider  $2^{nd}$  the motion and it passed unanimously.

The clerk's report of the October meeting was reviewed. Schattschneider made a motion to approve the report as written. Sazama 2<sup>nd</sup> the motion and it passed unanimously.

The Treasurer's report showed receipts of \$12,435.92, disbursements of \$56,526.18 and working capital of \$312,395.89. Sazama made a motion to accept the report as presented. Schattschneider 2<sup>nd</sup> the motion and it passed unanimously.

Keith Freidsam trapped 6 beavers. His claim will be added to the claims for payment list.

There were 3 resolutions needed to allow Carol Nelson, Gary Schattschneider and Karen Marthaler to work as election judges for the township. All three were passed. The affidavits required to make payments were included with the claims. Carol Nelson was the only supervisor who served as an election judge. Gary and Karen took the training and were back-up judges. The claims for payment were reviewed. Sazama made a motion to approve the claims as presented. Schattschneider 2<sup>nd</sup> the motion and it passed unanimously.

Road Reports.

Schattschneider drove the roads that were recently stripped. He was pleased with the work that he was able to see. (There was snow on some on the roads).

There were 3 access approach permits that were completed in October but were not mentioned in the minutes. The permit for Suhl's was approved at that meeting also.

The Winter Maintenance Resolution for Sand and Salt was passed and is included with the minutes.

A letter from Otter Tail County Highway Department was reviewed. They are requesting the township to consider taking over "CH 131", aka 430th. The Otter Tail County Highway Department letter provides an opportunity for options. An example could include paving the 0.8 mile of 430th Street (Polish 10?) between South Paul Lake Drive and CH 131(370th Avenue) while returning the south 1.0 mile of CH 131 (370th Avenue and 423rd Street) to gravel. Future discussions could include CH 123, with potentially different surfacing and load weight restrictions north and south of our paved 428th Street. Schattschneider suggested contacting Jeff Stabnow to help with this decision. This road was offered to the township in the early 1990s and was declined then. One advantage would be more money in the road allotment from the state. There are concerns with this road, for instance the cattle crossing in the road. Sazama made a motion to have Stabnow look at the road and review the data from the county that is available online. Is it feasible? What should we ask for as far as resurfacing? Should it stay asphalt or go to gravel? Stabnow will be asked to present a report at the December meeting. Schattschneider 2nd the motion and it passed unanimously.

Jeff Wells from Dead Lake Township was present to discuss 380<sup>th</sup>, south of State Hwy 108 to the north side of the tracks. Edna does not plow this road in the winter. There is a stretch of the road that fills in when the wind blows and would be very difficult and costly to keep open. This is a posted minimum maintenance road. There are 3 residents that live on this road when it enters into Dead Lake Township. These residents do have another route to main roads. Dead Lake Township would like this portion of the road plowed until the snow gets too deep. The main objection to this is that residents would not know when the road would be blocked by snow. It is not possible to see the problem area in the road from the intersection so a driver could make the turn, believing the road to be open and then come upon a snow bank blocking the road. One of options discussed would be to post a "No Winter Maintenance" sign at the intersection. It was determined that the sign should be ordered. Signs are made as ordered and it is difficult to determine how long it will take to get the sign. If it is ordered now it could be here before the snow gets deep. There is also a need for a minimum maintenance sign at the intersection of 403<sup>rd</sup> ad 380<sup>th</sup>.

There was a discussion of the concrete dumped on the shoulder of the road at the intersection of 395<sup>th</sup> and 405<sup>th</sup>. It looks like a pumper truck emptied the last of its load there. Sazama contacted residents in the area who recently had concrete work done to find the name of the concrete suppliers. Surprisingly, none of the concrete suppliers admitted to dumping

concrete on the road. Sonnenberg agreed to take care of this problem soon as it will become a bigger problem if left until Spring. The priority report for Sub-contractors was reviewed. The "No Dumping" signs for Heart Lake Road are here and ready to be installed. The concrete previously mentioned is on the list. The 3 road repairs that were not done this Fall are scheduled for next Spring. This would be the dip at 38182 N Little McDonald, the dip at the corner of 395th and 450<sup>th</sup> and the winter bump 455<sup>th</sup> near the intersection with E Little McDonald Dr.

The unfinished business items remain:

Ditches - brushing, tree removal, spraying

Traffic control

Traffic sign inventory

Proposed schedules for continuing maintenance

In other business the request for reimbursement of some election expenses because of COVID has been filed. This is the grant that will reimburse 80% of the amount we request. Total request was \$418.44, refund should be \$334.75. The meeting was adjourned at 8:41 p.m.
