This will be published and notice will be posted. A thank you letter was signed by all Board members thanking them for the years and years of renting. The annual audit of the books will be held at the end of the February meeting.

There was some discussion of items that need to be included in the annual meeting. These included: increased road budget, ideas for where to post official notices, and alternative meeting dates for regular monthly meetings that can not be held for any reason. The annual meeting agenda will be finalized at the February meeting.
