

The meeting was called to order at 8 pm and began with the Pledge of Allegiance.

Carol Nelson, Dennis Sazama, Bill Norris, Echo Dockter and Karen Marthaler were present.

The agenda was reviewed, a discussion of crack seal was added to the Road Authority report. A motion was made, seconded and passed unanimously to accept the agenda with this addition.

The Clerk's report was reviewed. A motion was made, seconded and unanimously to accept it as presented.

The Treasurer's Report was presented . It showed receipts of \$1,896.21, disbursements of \$180,044.82 and working capital of \$284, 217.50. A motion was made, seconded passed unanimously to accept the reports as presented.

A motion was made to have South Paul Lake Road, Spur Road, 380th Ave, 430th St, and 460th St striped by LotPros LLC. The motion was seconded and passed unanimously.

There was a discussion concerning the weed spraying. It was agreed that Carr's should spray again in the Fall. Carol Nelson will arrange for this to happen. This will include a notice published in the paper and on the website.

The Claims for Payment were reviewed. A motion was made, seconded and passed unanimously to pay the claims as presented. There was a comment from the residents present that the dust control this year did not last as long, or work as well as last year.

The Road Report discussion included several items:

Francis Genereux presented a road petition to extend East Big McDonald Trail from the first cul-de-sac to the second cul-de-sac. The extension would be .3 of a mile.

The Edna Township Road Specs were reviewed and it was determined that they should not be changed.

Dennis gave the Road Authority report. The repaving work on South Little McDonald and Spur Road is done. After some discussion a motion was made, seconded and passes unanimously to have Dennis contact Ottertail Aggregate to do the shouldering work. They have the machine to do this work, and the work they did for Rush Lake looked good. This is to be done as soon as possible. The motion was seconded and passed unanimously Dennis is recommending that Edna Township buy crack seal material for next year now because of the price. MaxSeal is the brand name. Bill will call and make the arrangements for 6 pallets.

All correspondence was emailed to the Board prior to the meeting.

A motion was made, seconded and passed unanimously to buy 194 chevron signs and posts to complete the road sign project. A motion was made, seconded and passed unanimously to have Echo find a 4 drawer file cabinet and have it delivered to the Dent Community Center.

The meeting was suspended at this point and it will be resumed at 8:30 am on Sunday morning at the Francis Genereux home on East Big McDonald Trail. The only item that will be discussed when the meeting is resumed will be the petition to extend the township road.

The following notes were submitted by Carol Nelson.

On August 21, 2016, at 8:30 a.m. the Supervisors Norris, Sazama, and Nelson and Jeff Stabnow met with Mr. & Mrs. Genereux and their neighbour at 42336 E Big McDonald Drive to discuss the possibilities of Edna Township maintaining that road. Their two homes are on the final stretch of the road. Their section of the road is gravel, narrow &

has overhanging large trees and bushes. Big McDonald Road from County Hwy 35 to where a gravel road begins is 1.4 of a mile. There had been a turn-a-round established approximately 0.4 of a mile from the asphalt. It is grown over now. Up until the first cul-de-sac, the road is an Edna Township road. Approximately 0.3 mile further west, is fencing just before the road to the two houses. There is room for a small turn-a-round there. There is a garbage truck that does pickup at their homes during most of the year. That truck turns around in the Genereux driveway. Both homeowners tell the Supervisors they would like winter road maintenance up to their homes. No promises were made.

At 9:30 a.m., Supervisor Norris adjourned the meeting.
