EDNA TOWNSHIP MEETING AGENDA May 15, 2018 www.ednatownship.org

The meeting was called to order at 8 pm. and began with the Pledge of Allegiance.

Bill Norris, Dennis Sazama, Carol Nelson, Karen Marthaler and Echo Dockter were present.

The agenda was reviewed and the following items were added; Dennis Lindee – culvert application, Mallard Loop, and Sybil Lake Trail. Sazama made a motion to accept the agenda with these additions. Norris seconded the motion and it passed unanimously.

The minutes from the April meeting were reviewed. Norris made a motion to accept the minutes as presented, Nelson seconded the motion and it passed unanimously.

The Treasurer's report showed receipts of \$37.71, disbursements of \$25,511.80 que working capital of \$433,928.13.

Sazama made a motion to accept the report as presented, Nelson seconded the motion and it passed unanimously.

The claims for payment were reviewed. Sazama made a motion to pay all claims, Norris seconded and the motion passed unanimously.

Road Report

The results from Bid opening on April 30, 2018 list Marks Sand and Gravel as the low bidder. They were the low bidder on the Otter Tail County Highway 4 project (Vergas to Dent). Norris made a motion to accept the low bidder as the winner of the contract, Sazama seconded the motion. There was some discussion about why this bid was lower than the rest and why there was such a wide range of bids. The motion passed unanimously. The contract was signed. Jeff Stabnow will notify Mark's Sand and Gravel. The tentative schedule is July.

Bid opening for the sealcoat projects was the next item. Quotes were received from Morris Sealcoat and Asphalt Preservation Company Inc. APCInc is the lower quote. Sazama made a motion to accept the APCInc quote, Norris seconded the motion and it passed unanimously.

Dust control was discussed. At this time no one has chloride. When contractors have the chemicals Devils Lake road, Kerbs Lake road, 355th Ave, Wolf Lake (380^{th),} Sybil Lake Rd, and Jackim Road are on the list.

There was discussion regarding reshaping the East Little McDonald Road so that it drains toward the swamp/slough. The road will be crowned so that the runoff does not all go toward the lake. There is a \$20,000 contingency fund for landscaping included in the estimated costs of the project.

The first draft of the Donation Policy was reviewed (attached). This is not a new policy, but it may have been the first time it was written. Nelson made a motion to adopt the policy as presented, Sazama seconded and the motion passed unanimously. The Board agreed the policy should be posted on the website.

The 911 sign by the Anderson's on East Little McDonald is still leaning. Tory will make sure it is fixed.

Dennis Lundee submitted a culvert application. The application is complete.

The Mallard Loop road was discussed. There is a dispute between property owners about the road. The Township position is that the only part of the road that is a township road is the part that has been maintained by the township. There is no action the Board can take.

Sybil Lake Trail. There is a mailbox in the cul-de-sac. This will be moved and the cul-de-sac reestablished where it is supposed to be. Norris made a motion to reestablish the cul-de-sac on Sybil Lake Trail, Sazama seconded the motion. Both supervisors agreed that the landowners have been informed and that this is the correct action. The motion passed unanimously.

In other business it was noted that Edna Township is on the list to use the electronic poll book for the upcoming elections. There will be training in Fergus Falls on May 16 and Echo and Carol Myhre will be attending.

The on going issue with the IRS has been resolved, by assigning Edna Township in Minnesota a new EIN. Echo will begin the process to make this change.

The meeting was adjourned at 9:05 pm.
